These two Live Online MSHA courses provide safety training requirements to meet New Miner, Experienced Miner and Annual Refresher as required for independent contractors and grantees in metal/non-metal surface mines. New Miner and Experienced Miner courses will be required to receive a mine/site tour before the participants MSHA 5000-23 Form can be completed and before the employee can work at an MSHA regulated site or mine (Sept. 2017) as part of the required "Introduction to Work Environment." In addition, Lake Superior College (LSC) can provide MSHA training to sand and gravel operations for those companies that incorporate Lake Superior Colleges training tasks within their own MSHA submitted training plan.
